Purpose, scope and objectives

Request

- letter of 4 June 2018 (from Danish Minister for Higher Education and Science, Tommy Ahlers, to Commissioner Carlos Moedas)
- external advice and operational recommendations to the Danish authorities on possible reforms in the national R&I system
- important initiative as part of the strategy 'Denmark -Ready to seize future opportunities' where the Government is outlining its objectives for future research and innovation
- Timing: January 2019 September 2019

Objectives & scope

 Overall objective: examine the Danish knowledge-based innovation system as a whole, including the value chain from research to innovation in established and new companies

Scope:

- Assessing the overall effectiveness of the Danish R&I system, outlining its strengths and weaknesses
- Focus areas:
- 1) Knowledge based technological service for businesses;
- 2) Collaboration, networking and matchmaking, and
- 3) Knowledge-based entrepreneurship.

Main outcomes

- Evidence-based limited set of operational recommendations/policy messages
 - Focused
 - Well-justified
 - Political/policy relevant
 - Case studies/ country boxes (good practice examples)
- Feedback mission with public event and diffusion of results
- Follow-up: country's responsibility
 - Post-Peer Review or Specific Support as an option

Peer Review: Success factors

Building on successful experiences for R&I reforms

Key to success **before** the review

- Political commitment and trust
- Optimal timing in political/ policy cycle
- Tailor-made to specific country needs

Key to success during the review

- Focus on key R&I policy areas (preparation important!)
- Mix of experts' and peers' skills
- Fully involve stakeholders
- Limited set of 'key' actionable recommendations
- Acknowledgment of the contribution of the different actors

Methodology

Phase 1: **DESIGN and KICK-OFF**

Commitment, design and scope of exercise, selection of experts & peers

Kick- off meeting: agreement on scope, meetings, roadmap. First draft background report and self-assessment. Engagement of all relevant stakeholders

Phase 2: In-depth ANALYSIS and PEER REVIEW sessions

Background analysis
Self-assessment by host country

First Peer Review session- assessment Second Peer Review session- feedback

Phase 3: **REPORTING**

Discussion of draft Peer Review report with national authorities of the host country

Final report and recommendations

Presentation to all relevant stakeholders

Roles and responsibilities

Responsibilities: Chair

- Coordinates the conceptual work of the panel of experts and assign thematic responsibilities to the experts
- Coordinates the discussion on key questions/issues
- Chairs the meetings (internal, and with stakeholders)
- Makes proposals for the structure, main messages and recommendations of the report and discuss it with the panel and the Commission services
- Overall responsibility for drafting the Policy Messages
- Assesses the quality of the reports

Responsibilities: Rapporteur

- Actively supports the Chair:
 - on structuring the report
 - in moderating the meetings and acting as rapporteur writing the minutes (key points)
- Drafts the reports (draft, final, assessment) based on the written contributions of the experts

Distribution of work within Expert Team

- Peers and independent experts (and the PSF Team support)
- Each expert is responsible for one or more thematic areas based on his/her expertise:
 - Analyse evidences, studies and other documentation
 - Provide input for issues/questions to be addressed to the national authorities and stakeholders during the interview phase
 - Provide analytical inputs/ country-specific good practice exemples
 - Draft relevant sections of the analysis, conclusions and policy recommendations
 - Moderate discussion in meetings in the area of his/her expertise
