

# **Institutional Repositories**




# Repositories (1)

- 2008 : ORBi at Université de Liège
- Since 2008 : All FWB universities have or share a repository

 Under development: meta-portal harvesting all OA repositories (at F.R.S.-FNRS)


# Repositories (2)

# Repositories (3)

- RéFéR OA « Grey Literature » repository of the Ministry of the FWB (2017) (<u>www.recherches.cfwb.be</u>)
  - Research sponsored or produced by the Ministry in its areas of expertise
  - OAI-PMH protocol for interoperability
  - Already more than 600 research projects (and 689 documents) openly accessible
  - Future collaborations with public organizations

# Mandates (1)

- Université de Liège mandate (2007-2014)
  - ID/OA (Immediate Deposit Optional Access)
  - Deposit of the full text for each scientific article published since 2002
  - Open access according to publishers' policies
  - "Stick and Carrots"
    - Publication lists from ORBi for all nomination,
       promotion or credit allocation
    - Better visibility and accessibility

- Mandates (2)
- F.R.S.-FNRS mandate (2013)
  - Inspired by the ULiège mandate
  - Deposit of the full text for each scientific article published since 2008
  - Publication lists (postprints) from university OA repositories for evaluating and awarding research credits
  - APCs up to 500 Euros

- Mandates (3)
- Decree on Open Access of 3 May 2018
  - Concerns
    - all research that is (even partially) publicly funded
    - all articles published from 14 September 2018
  - Postprints to be immediately deposited
  - Embargo periods of 12 (STEM) or 6 (SSH) months before open access

### Mandates (4)

#### The decree:

- Promotes the dissemination of research results;
- Allows each student and researcher, all over the world and especially in the most disadvantaged regions, unhindered access to research;
- Reinforces the potential of research to produce impact, at scientific and societal level;
- Increases the visibility of researchers and their work.

# Mandate (5)

Art. 7. Any person, committee or scientific commission of the French speaking Community [Wallonia-Brussels Federation] responsible for evaluating individual or collective files within the framework of nomination, promotion, allocation of research credits, takes into account, for the evaluation of the publications of the researchers and under pain of nullity, the lists generated from the institutional digital repositories [...] to the exclusion of any other list.
